



Shine Dance Festival 2021 - DANCER Release Waiver

Each dancer must have a release signed by a parent or legal guardian before performing at a Shine Dance Festival event. If you have more than one child participating, you may include them all on one form. Thanks for your cooperation.

In consideration of being allowed to participate in a SHINE DANCE event and related activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participating in events take certain incumbent risks including, but not limited to, sprains, pulled muscles, broken bones, possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS Shine Dance Festival and All That Jazz Enterprises Inc. their officers, officials, agents, and/or employees, other participants, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY GRANT PERMISSION to All That Jazz Enterprises Inc. use of any fan mail, photographs, and/ or videos, which will become the property of All That Jazz Enterprises Inc., as well as printing of names for advertising, promotional and publicity purposes and tagging and reposting images, video, and testimonials on Shine Dance event websites and social media.
